### Boston Junior Terriers Hockey Refund Policy

# 1. Medical Discharges

a. If a child is medically unable to attend a camp, clinic, lesson or continue playing on a team due to a documented injury or illness, at the sole discretion of the company, we may apply the funds paid to future registrations. The company is not obligated to refund payments made. For camps and clinics, a credit (minus administrative costs of 10%) will be issued for credit requests received prior to the start of the camp or clinic. No credits will be issued after the start date of a camp or clinic.

## 2. Tryout Fees

a. Any player that registers for tryouts and later decides either not to tryout or not to accept the team placement after tryouts is not eligible for their funds to be returned. It is the guardian's decision to register for the tryout and regardless of the company/coaches' team placement decision, the funds will not be returned. The company may decide to, at the request of the guardian, apply the tryout fee to a future registration. This decision is at the sole discretion of the company.

#### 3. Team Tuitions

### a. Deposits

i. Deposits for all teams are posted on the website. Deposits reserve the spot for the child to hold a roster position and are nonrefundable and cannot be applied to future registrations. Deposits are due at the time of the contract being signed, no later than April 1.

## b. Payment Terms

i. Each team's tuition is split between the deposit and the remaining balance and is to be paid on time, on the 1st of each month. All tuition must be paid in full no later than September 1. All funds received are non-refundable. If the tuition is not paid in full by September 1, the child may be asked to no longer attend games, practices and/or skills and could lose their position on the roster. Further, the company will seek any outstanding payment that was committed to since the child took the spot of another child that could have paid said tuition.

# c. Early Payment Discount

i. Tuition paid in full by April 1, will receive a 5% discount.

## d. Late Fees

i. If the tuition is not paid in full by September 1, the company reserves the right to charge a 10% late fee per month on the outstanding balance.

### e. Alternates

- i. Players can play in up to 12 Terrier games throughout the season, at the sole discretion of the head coach and the coach is under no obligation to play an alternate in any game(s).
- ii. Players playing on other Terrier teams: some players are asked to be a full-time player on one Terrier team and an alternate on another Terrier team. Because the player is paying full tuition on a Terrier team, in this case, they do not pay the tuition for the alternate position. This circumstance is rare and usually applies in the instance of goalies, when one team needs a back-up.
- iii. Alternate players are NOT permitted to play in the EHF playoffs.

## f. Players Leaving the Team

i. If a player leaves a team for any reason, other than a documented medical reason, the tuition paid will not be applied to future registrations.

### 4. Miscellaneous

### a. Returned Check Fee

i. A returned check fee of \$25 will be applied to any registrants account for a check returned for a closed account, insufficient funds or any other reason. The fee must be paid before any further purchase can be made.
